

# Mega Fun Party Terms & Conditions

1. A non-refundable deposit of £50 is required to secure a party booking.
2. The balance of the price and confirmation of the number of guests must be made at least 7 days prior to the party date otherwise Jack in the Box Club will presume that the party is no longer required.
3. Once you have confirmed your numbers, the total price of the party will be based on this number irrespective of whether a lesser number turn up.
4. We will endeavour to accommodate any guests in excess of the number booked and confirmed, but cannot guarantee to do so if the total numbers exceed the maximum permitted in the party room. Please let us know as soon as possible if you wish to increase the number. Payment is required for additional guests at the time that you notify us of the increase or on the day of the party if we are not notified in advance.
5. In the event of cancellation by you within 7 days prior to the date of the party, the total party price remains payable and is not refundable.
6. Subject to our sole discretion, we will endeavour to re-schedule your party, without the loss of the deposit, to an alternative date if this is necessary due to illness or other significant unforeseen circumstance.
7. Only invited party guests will be admitted as part of the party. Uninvited siblings will be charged the normal Mega Fun admission price, less a £2 discount, and will not be permitted to join the party for food.
8. You are required to provide us with a list of guest names at least 1 day before the party. If any children arrive who are not on the guest list we will ask you if you would like to add them to the party. You are required to pay for all additional guests to whom you agree.
9. The normal Mega Fun Rules of play apply whilst you and your guests are at Mega Fun.
10. The children in the party remain the responsibility of the parents and carers at all times. A minimum of one adult per 5 children is required to provide adequate supervision.
11. All children must wear socks. These can be provided if necessary at an additional cost.
12. Please ensure that you have contact details for all of the children under your supervision at your party in the unlikely event of an emergency.
13. We may cater for children with allergies under the guidance of the parents/carers. However, we accept no liability for any allergic reaction which may occur.
14. The party child and their parents/carers should arrive no more than 10 minutes before the scheduled start time of the party.
15. Please ask your guests to arrive at the scheduled start time of the party.
16. We will be happy to cut and wrap your birthday cake. Please ensure that the cake will adequately provide for the number of guests at your party.
17. Please provide candles for your cake. For safety reasons, re-lighting candles, sparkling candles and indoor fireworks are not permitted.
18. For safety reasons, helium and other gas filled balloons are not permitted unless they are secured to a weight which is sufficiently heavy to prevent the balloon floating into the roof area.
19. Crackers, party poppers, piñatas, confetti and other items with small parts are not permitted.
20. The use of face paints is not permitted as we find that this rubs off on to the play equipment and then onto clothing.
